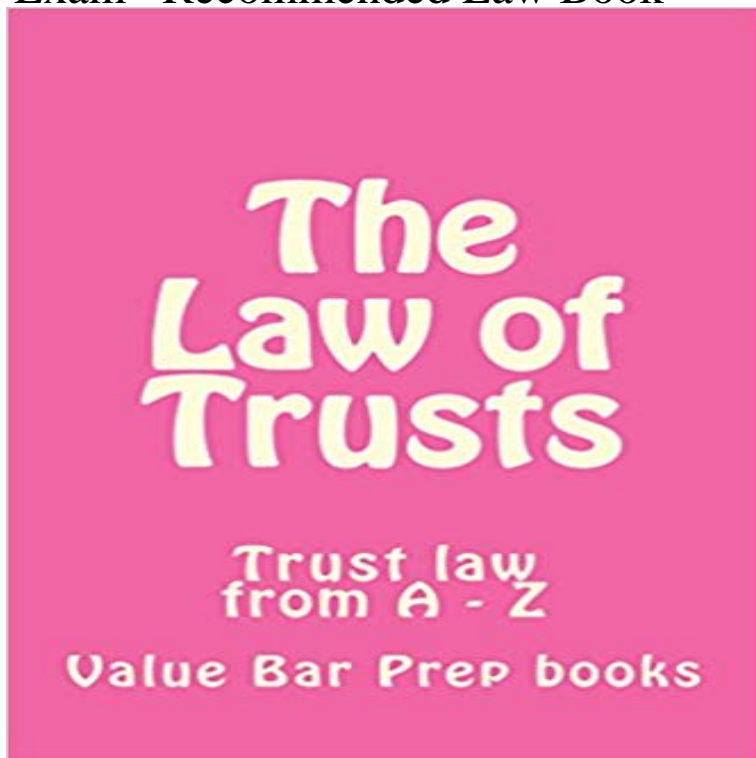

Express trusts tend to be the only ones tested under Trusts law per se - all other types of trusts tend to be tested under Remedies. However, public trusts may be tested.
