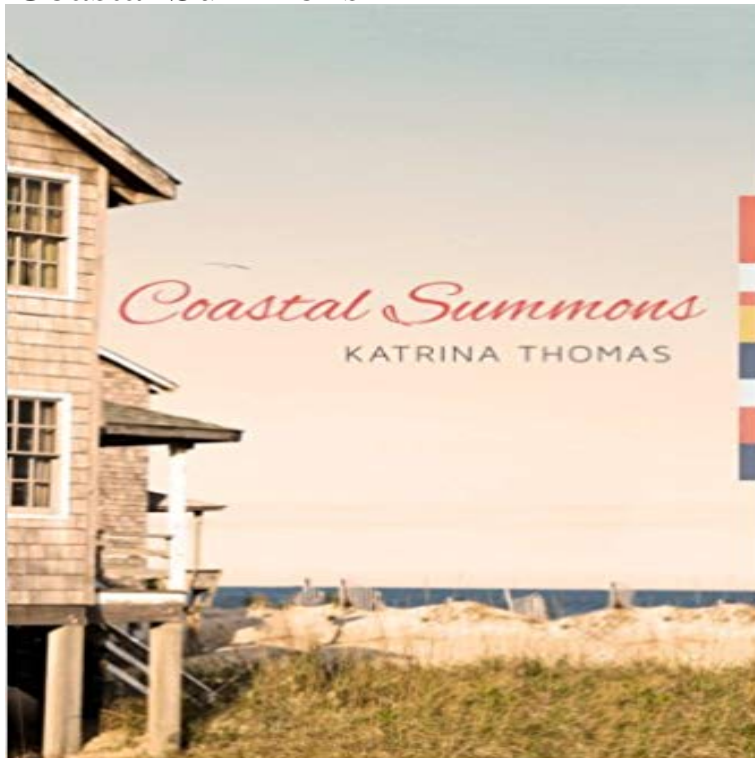


Coastal Summons
