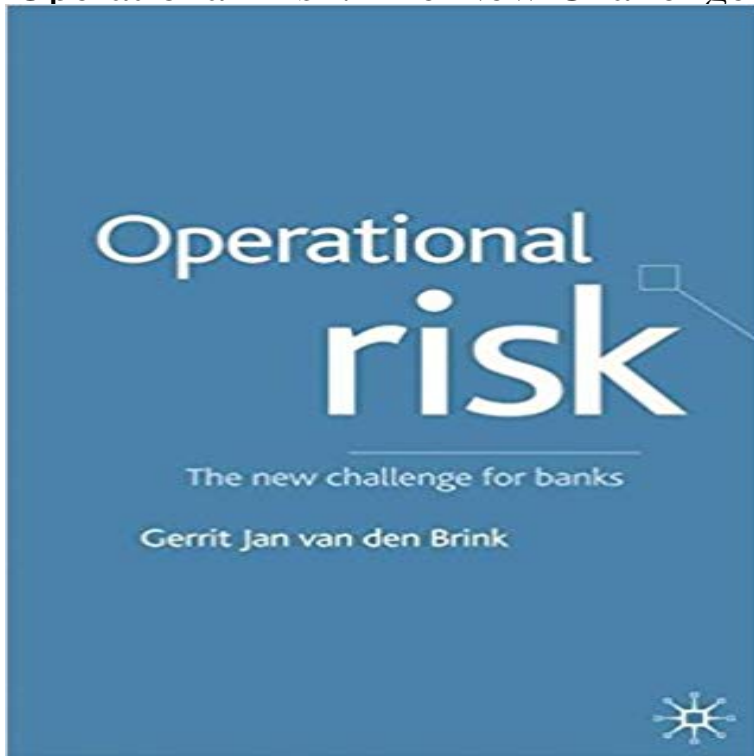


## Operational Risk: The New Challenge for Banks
