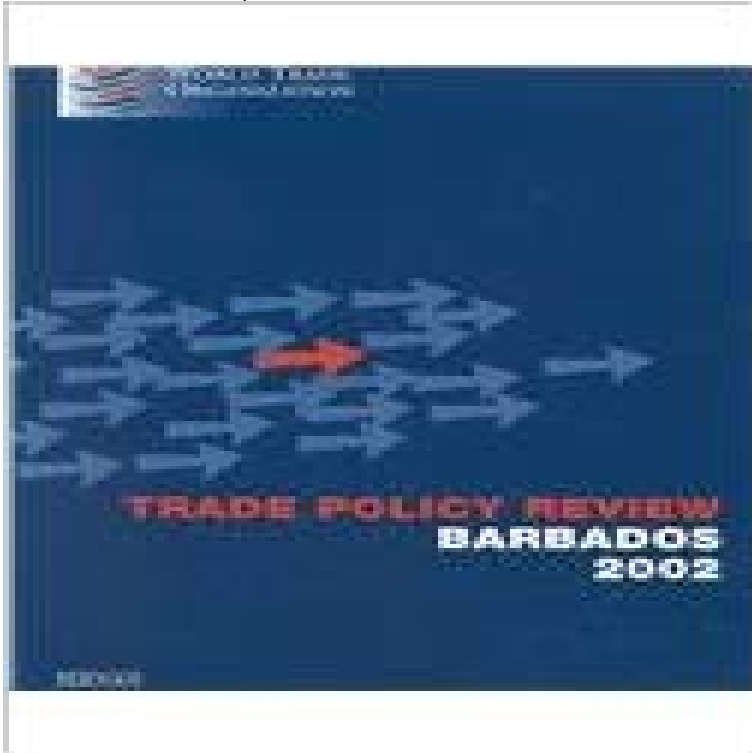


## Trade Policy Review: Barbados 2002
